A parent of a child in the Four-Year Old program at St. Willibrord, expressed her concern regarding a book read to her child's class, as part of the sexuality program, that she felt was not appropriate; she asked to know how the School Board establishes age-appropriate reading materials for students.

- Operations The Chair was absent, and the Vice-Chair was not prepared, therefore the report was given by Mr. T. Savoie. The committee reviewed the document "Role of Chairs & Vice-Chairs", summer projects, grass cutting and snow removal contracts, Radon testing, and the year-end Trafics report.

### **Special Needs Advisory Committee**

Commissioner B. Bourdeau noted that SNAC will be meeting, in person, on October 5.
