Call to Order & Opening Remarks

Adoption of the Agenda

Public Question Period

A mother of a student attending CVR High School, by choice, indicated the steps the parents have taken with the MRC Haut St. Laurent for their children to be allowed on the bus that goes to CVR; she asked what the School Board is doing to support them?

Resolution #CC22-11-01-001

Letter to the MRCs of Haut-St-Laurent and Roussillon

It was moved by Vice-Chair R. Ledoux that the Council of Commissioners write a letter to the prefects of the MRC Haut-St-Laurent and the MRC Roussillon, with copies to the MNAs of the region, indicating their displeasure with the removal of our students from this public transportation service.

Recognition

Former Chair David D'Aoust

The former Chair of the New frontiers School Board was recognized for his dedication and service to the students, staff and citizens of the New Frontiers School Board community and presented with a certificate to that effect.

The Chair recognized Commissioner D. Hoshowatiuk for her service as the Commissioner representing secondary school parents, and Commissioner B. Jeuris for his service as the Commissioner representing elementary school parents. He thanked them both for their dedication, acknowledging the time they gave – including several evenings – away from their families in order to serve others.

Resolution #CC22-11-01-002

Director General Rob Buttars

Whereas the Canadian Association of School System Administrators (CASSA) honours members who have exhibited exemplary leadership ability and enhanced school administration, with the Xerox EXL Award; and whereas this recognition normally takes place at the annual CASSA Conference; and whereas Mr Rob Buttars was nominated by the Association of Directors General of English School Boards of Quebec (ADGESBQ); and whereas Mr Buttars' nomination included a letter written by the ADGESBQ President, Mr Mike Dubeau, and included the following text:

"Since 2013, Rob has proudly served as the Director General of the New Frontiers School Board, a school district that services suburban and rural communities south of Montreal. The challenges in Rob's district include a small population spread out over a large geographic territory as well as Indigenous and socio-economically marginalized communities.

In these varied roles, Rob has placed student success at the heart of his leadership. All of the initiatives he has led have been focused on helping vulnerable students achieve success. "Rob's leadership has had a positive impact on the entire province of Quebec. He has served as President of ADGESBQ and remains on the executive of this committee as Vice-President. In this role, he interacts directly with other system leaders and the Ministry of Education. Rob is currently the chair of the English Language Vocational Education Council (ELVEC), a provincial committee that advocates for and strengthens vocational training program opportunities across the province. He is also the DG representative on the Entente Canada-Quebec table, a committee that oversees the distribution and management of minority language funding that the English education network receives annually from the federal government. Rob has also sat on numerous committees to increase student success and improve curriculum throughout his educational career." and; whereas Mr Buttars' nomination was one of the top three accepted by the CASSA Executive; and whereas this year's Xerox EXL Award was bestowed on Mr Bevan Daverne, Superintendent for the Golden Hills School Division, from Strathmore Alberta; and whereas the two runners-up, Mr Buttars and Mr Philippe Brulot, were also recognized at this year's conference and in the Leaders & Learners CASSA Newsletter;

Therefore, it was moved by the Vice-Chair R. Ledoux that the New Frontiers School Board formally recognize Mr Buttars' contributions to the Quebec public education system, and across Canada; and that Mr Buttars also be recognized for his dedication to the New Frontiers School Board and for the many contributions he has made locally for the students, staff, families, and communities we serve.

Resolution #CC22-11-01-003

Réseau du Sport Étudiant du Québec (RSEQ) - Membership Fees

Whereas the Réseau du Sport Étudiant du Québec (RSEQ) is the governing body of primary and secondary school, collegiate and university sport in Quebec; and whereas the New Frontiers School Board (NFSB) has been affiliated with RSEQ Montérégie for many years; and whereas the NFSB would like to renew the affiliation for the upcoming year; and whereas the Council of Commissioners is required to adopt a motion confirming our sports affiliation with RSEQ Montérégie for the 2022-2023 school year;

Therefore, it was moved by Commissioner K. Van Droffelaar that the New Frontiers School Board pay to the Réseau du Sport Étudiant du Québec - Montérégie a base affiliation fee (\$363.30) and a per capita membership rate at elementary and secondary level based on the September 30, 2022, enrolments at all our schools of twenty-five cents per student (\$0.25) at the elementary level and twenty-six cents per student (\$0.26) at the secondary level; and that a teacher (to be determined) secondary level and Kara Johnstone (elementary level) be designated as the Board's representatives to the Réseau du Sport Étudiant du Québec.

Resolution #CC22-11-01-004

Authorization to Participate in a Purchasing Tender CAG-2022-7512-50 - Network Equipment

Whereas the New Frontiers School Board (NFSB) renews and upgrades the network on a regular basis; and whereas the Centre d'acquisitions gouvernementales (CAG) tendering services has a tendering offer which has criteria that meets the needs of the NFSB; and whereas the contract would be in place for five years and will begin on March 1, 2023; and whereas the contract would end on February 29, 2028, and have the possibility of a two-year renewal; and whereas the anticipated total five-year cost for the tender of network equipment is estimated at \$221,000 which exceeds the authority of the Director General as provided for in By-Law BLA "Delegation of Powers by the Council to the Director General";

Therefore, on the recommendation of the Educational Services Standing Committee, it was moved by Commissioner K. Van Droffelaar that the Council of Commissioners authorize the New Frontiers School Board to enter into a contract with the recipient of the *Centre d'acquisitions gouvernementales* tender number 2022-7512-50 for the purchase of network equipment, including Wi-Fi routers, infrastructure switches, firewall, etc., starting in the spring of 2023; and that the Director General, or in his absence, the Assistant Director General be empowered to sign and give effect to such contract.

Resolution #CC22-11-01-005 Borrowing Plan – Line of Credit

Whereas, in accordance with section 78 of the Financial Administration Act (R.S.Q., chapter A-6.001), the New Frontiers School Board (the "Borrower") wishes to establish a borrowing plan, allowing it to borrow by line of credit from the Minister of Finance, as the person responsible for the Fonds de financement, to finance the portion of its investment projects subsidized by the Ministry of Education notably the projects under the responsibility of the Société québécoise des infrastructures (the "Projects"); and whereas the amount and maturity of the loans to be contracted under this borrowing plan shall not exceed the amounts authorized from time to time by the Minister of Education, in accordance with the Education Act (R.S.Q., chapter I-13.3) and the Financial Administration Act re for these Projects; and whereas the Projects will be funded solely through the Minister of Finance, as the lead for the Funding Fund; and whereas, for projects under the responsibility of the Société québécoise des infrastructures, temporary financing is initiated by the latter, on its credit; and whereas the temporary financing of projects under the responsibility of the Société québécoise des infrastructures must periodically be transferred to the Minister of Finance, as the person responsible for the Financing Fund, on behalf of the Borrower, at the request of the Société québécoise des infrastructures; and whereas it is opportune, to this effect, to authorize this borrowing plan and to approve its terms and conditions; and whereas, in accordance with Section 83 of the Financial Administration Act, the Borrower wishes, within the framework of this borrowing plan, that the power to borrow and the power to approve the terms and conditions of the loans be exercised by at least two of its officers; and whereas the second paragraph of section 83 specifies that, in the case of a short-term loan or line of credit, the power may be exercised by a member of the personnel authorized by the organization, who may act alone; and whereas this borrowing plan must be authorized by the Minister of Education in accordance with the Education Act and the Financial Administration Act; and whereas it is necessary to renew any line of credit agreement entered into between the Borrower and the Minister of Finance, as the person responsible for the Financing Fund;

Therefore, it was moved by Commissioner A. Pirani:

- 1. That, subject to the required authorization from the Minister of Education, the Borrower be authorized to institute a borrowing plan enabling it to borrow by line of credit from the Minister of Finance, as the person responsible for the Financing Fund, to finance the portion subsidized by the Minister of Education of its investment projects, in particular the projects under the responsibility of the Société québécoise des infrastructures (the "Projects"), according to the following limits and characteristics:
 - a) the interest rate payable on the loans will be established according to the criteria determined by the government under Order in Council number 513-2022 of March 23, 2022, as such Order in Council may be amended or replaced from time to time;
 - b) Borrowings under the line of credit will be made under the line of credit agreement with the Minister of Finance, as manager of the Financing Fund, in accordance with the terms and conditions set out therein;
 - c) the amount of borrowings under the line of credit shall not, at any time, exceed the amount authorized from time to time by the Minister of Education under letters of authorization issued by him for such Projects; and
- 2. That the Projects be funded solely through the Minister of Finance, as the lead for the Financing Fund; and
- 3. That, for projects under the responsibility of the Société québécoise des infrastructures, loan requests by line of credit be initiated by the latter; and
- 4. That for the purpose of determining the amount of borrowings referred to in paragraph 1(c), only the balance of outstanding borrowings from the Minister of Finance, as the person responsible for the Financing Fund, be taken into account; and
- 5. That the Borrower be authorized, except for line of credit borrowing requests initiated by the Société québécoise des infrastructures, to submit to the Minister of Finance, as the person responsible for the Financing Fund, a transaction confirmation to acknowledge each borrowing or each repayment of capital or interest on the line of credit; and
- 6. That, when a request is initiated by the Société québécoise des infrastructures, the capital of the line of credit loan be paid, on the date of the loan, to the Société québécoise des infrastructures, for and on behalf of the Borrower, in reimbursement of expenses incurred for the Borrower's investment projects, the management of which has been entrusted to it; and
- 7. That the Director General or the Assistant Director General of the Borrower, provided that both are acting jointly, be authorized, for and on behalf of the Borrower, to execute the Line of Credit Agreement, to consent to any additions or amendments not materially inconsistent with the provisions hereof and to do all acts and execute all documents necessary or useful to give full effect to the Line of Credit borrowings; and

- 8. That in addition to the officers identified in paragraph 7, the Director of Financial Resources or the Coordinator of Financial Resources, or the acting Coordinator of Financial Resources of the Borrower, be authorized, for and on behalf of the Borrower, to execute under this borrowing plan any transaction confirmation required to enter into a line of credit loan or to make a repayment under this line of credit; and
- 9. That this resolution replaces all previous resolutions adopted for the same purpose.

Unfinished Business / Business Arising / General Order

At the Council meeting of October 4, 2022, the following questions were asked during the first Public Question period:

- 1. Age-Appropriate Reading Material
 - **Question:** A parent of a child in the Four-Year Old program at St. Willibrord, expressed her concern regarding a book read to her child's class, as part of the sexuality program, that she felt was not appropriate; she asked to know how the School Board establishes age-appropriate reading materials for students.
 - **Response:** As per the Education Act, reading material is approved by the principal, who is recognized as the pedagogical leader in the school. It was further noted that the book in question, was not actually read to the class but discussed at Meet the Teacher Night.
- 2. MRC Haut St-Laurent Transportation Issue
 - **Question:** A mother of a child who attends Chateauguay Valley Regional High School by choice, via an inter-school transfer, asked that the School Board step in to help rectify the situation whereby the MRC HSL Department of Transportation is refusing students to use this free service, citing misbehaviour and/or a lack of space on the bus. **Response:** In accordance with School Board policy, transportation is not provided when families choose to send their children to a school other than their zoned school. That said, a special accommodation has been made to transport these students from Ste Martine to Howick Elementary School, where they then transfer to a CVR bus.

Second Public Question Period

There were no members of the public remaining.

Adjournment

There being no further business, the meeting was closed at 20:39 hours on a motion by Commissioner B. Ednie.
