### Pergola & Slab Installation - St. Willibrord Elementary School

Whereas St Willibrord Elementary School has requested permission to build a pergola and concrete slab on the school property; and whereas preliminary plans and specification documents were provided; and whereas Organizational Guide ECBC, "Procedures for the Installation, Relocation & Maintenance of Playground Equipment, or Other Exterior Installations" is being followed; and whereas this project has been approved by the St Willibrord Governing Board; and whereas St. Willibrord Elementary has raised sufficient funds to cover the cost of the project; and whereas the request for the required permits will be issued; and whereas a professional contractor will be mandated to oversee the project; Therefore, on the recommendation of the Operations Standing Committee, it was moved by Commissioner A. Pirani that the New Frontiers School Board's Council of Commissioners approves the project Pergola & Slab Installation as proposed by St. Willibrord Elementary school.

Ednie, Chair, reported on the meeting of April 18, 2023, at which the following topics were discussed: leaves, retirements, resignations, etc, the need to update Policy GBGA "Health & Safety", the draft administrative structure, and the Director General's Administrative Performance Plan.

Commissioner A. Pirani, Vice-Chair, reported on the meeting of April 18, 2023, at which the following items were covered: updates from Material Resources and Financial Services, Amazon for Business account, the pergola project at St. Willibrord.

### **Professional Relations Committee/NFAA**

The Chair reported on the meeting of April 27, 2023, providing an update on the Clevr Absence Management System 2.0, indicating the new Regulation was deposited on April 12, 2023, but there are still questions regarding certain clauses, and noting that the administrative structure was presented for the Association to consult on.
