Resolution #CC23-05-30-001

Microsoft Licenses - Authorization to Renew for 2023-2024

Whereas the New Frontiers School Board (NFSB) makes use of the Microsoft software suite (Word, Excel, Teams, Outlook, etc.) which is software that meets the needs of public education in Quebec in terms of the requirements of the Ministry of Education for the security of information; and whereas these needs are currently met through the Microsoft A5 license; and whereas the licenses are available through the provincial supplier Softchoice as selected by the Centre d'acquisitions gouvernementales; and whereas the cost of the software license is \$128.27 + tax per user; and whereas the estimate for the New Frontiers School Board is up to \$150,000.00 + tax for the 2023-2024 school year; and whereas this amount exceeds the authority of the Director General as provided for in By-Law BLA "Delegation of Powers by the Council to the Director General";

Therefore, on the recommendation of the Educational Services Standing Committee, it was moved by Commissioner K. Van Droffelaar that the Council of Commissioners authorize to pay Softchoice for Microsoft A5 licenses for the provision of critical operational and management software for the 2023-2024 school year; and that the Director General, or in his absence the Assistant Director General, be empowered to sign and give effect to such contract.

Resolution #CC23-05-30-002

School Elections 2024 - Division of Territory

Whereas School Elections are due to be held in November 2024; and whereas one of the first tasks in the election process is the division of a school board's territory into electoral wards; and whereas the New Frontiers School Board would normally be entitled to eight electoral divisions based on the number of registered electors (11,109); and whereas Minister Bernard Drainville has responded positively to the School Board's request to maintain the 10 (ten) divisions it has had for the past number of years;

Therefore, it was moved by Commissioner K. Van Droffelaar that the New Frontiers School Board adopt the following division of its territory into 10 (ten) electoral wards which maintains the legal balance between the divisions:

Naming of Interim Assistant Director General, Secretary General, and Modified Structure

Whereas the administrative structure currently in place for the 2022-2023 school year provides for a combined position of Assistant Director General AND Secretary General, currently filled by Mr Mike Helm; and whereas Mr Helm has been named Director General as of June 1, 2023; and whereas a selection process to replace the Assistant Director General/Secretary General for July 1, 2023 is in progress; and whereas it is mandatory that all school boards have an Assistant Director General and a Secretary General named at all times;

Therefore, it was moved by Commissioner J. Largan that the Council of Commissioners appoint Cuthbert McIntyre as the interim Assistant Director General effective June 1, 2023; and that the Council of Commissioners appoint Luisa Benvenuti as the interim Secretary General effective June 1, 2023; and that the Transportation dossier remain with Mr Helm for the month of June 2023, after which it will be transferred to the Educational Services Director; and that in so doing, the Council of Commissioners adopt a change to the current 2022-2023 administrative structure that separates the positions of Assistant Director General and Secretary General until such time that the new Assistant Director General/Secretary General (combined) is named.
